## District 10 February Newsletter

Dear Neighbor,

Many of our District 10 neighbors have recently fallen victim to the rash of burglaries that have afflicted our neighborhoods. You may even be one of these victims. This is a situation that I do not take lightly. Having been the victim of a home burglary – while we were upstairs at home - I am very familiar with the unsettling emotions that come from having your home, your supposed safe haven, in an instant, become so vulnerable.

Concern, frustration, and anger were all at the forefront of my mind when my home was hit, and they continue to be as I hear about the many families affected by these insolent criminals. Your neighborhood is my neighborhood. Just like you, I made my home in District 10 with my wife and young sons because it has great schools and a reputation as a beautiful, clean, and safe place. Seeing those values being trampled on by hoodlums out to take advantage and make a quick buck on the backs of hardworking people only increases my concern and frustration. By banding together as a community and channeling those raw emotions into knowledge and diligence in looking out for one another, we can reverse this unfortunate trend and once again have peace of mind.

As your Councilmember, I have an additional responsibility to you to ensure the City is doing all it can to help. Please know I am doing everything in my power to get more resources to District 10. I requested of Police Chief Esquivel and of our Interim City Manager, Norberto Duenas, to whom he reports, whatever assistance they can provide to our residents. The Chief has dispatched some burglary suppression units in our area, as well as TABS cars, and I have called for additional units. I have also asked the City Manager to work with our Chief and police union leaders to allow us to contract with the CHP to provide routine traffic enforcement efforts so that our SJPD officers can remain focused on other serious tasks, such as solving this rash of burglaries.

Other efforts I am undertaking include making security camera and alarm technology classes available to you and working with a member of the community and the SJPD to host a ***Community Safety Meeting at Bret Harte Middle School on February 11th at 6:30 PM.***

In an effort to educate our District 10 residents about factual crime statistics and crime prevention techniques, my office, the San Jose Police Department, and District 10 resident Suzy Chang have organized this Community Safety Meeting. Neighbors will have the opportunity to ask questions of their Southern Division Police Officers, Crime Prevention Specialists, Mayor Sam Liccardo, and me. Suzy's hard work on this event is much appreciated and I thank her for partnering with my office and the SJPD to make sure this event goes well. In order to make the most of the time we have on the 11th, Suzy is collecting questions from residents ahead of time for the panel discussion. Of course, the police cannot do their job without your help, so fighting crime in our community must be a unified effort! I am encouraged when I attend Neighborhood Watch meetings around the district – several of which I have attended recently - to see residents ready to become more vigilant and support our police department in providing them the information they need to help put a stop to the burglaries.

I am also encouraged by the number of residents who have reached out to me to come up with creative and constructive ways in which we can work together to restore the peace and serenity of our neighborhoods. Many of our neighbors have also gone to work to organize their own streets and taken other steps to improve safety. As we have since my election two years ago, my staff and I have safety at the forefront of our priorities ways to ensure the continued safety of District 10. It is important to know that despite our best efforts, some factors are beyond the control of your City leaders, including the release of thousands of prisoners as a result of Prop 47's passage, together with the state's prison realignment program and voter-approved changes to the three strikes law. In fact, property crimes are up in many areas of the state, even in very wealthy areas. Regardless, we must focus on doing what we can to prevent crime in our own neighborhoods and communities.

I look forward to seeing many of you on February 11th. I think we will all come away with valuable tools that we can put into practice in making our neighborhoods safer. Please be assured that my staff and I are doing what we can to make sure District 10 remains beautiful, clean, and safe. **ARE WE SEEING THE EFFECTS OF PROP 47, REALIGNMENT, AND THREE STRIKES REFORM?**

This past year the voters passed Proposition 47, which some law enforcement professionals claim is directly related to the increase in property crimes. [Here is a link to information regarding Prop 47.](#)

Since the implementation of Proposition 47, 535 inmates have been released out of jail in our County, alone. I am sure it will take years to determine if this new policy change will save taxpayers money, but in the meantime we are left to wait and see if drug treatment, rehabilitative programs, and job training programs positively affect the recidivism rate, or if many return to the behaviors, such as property crime, that landed them in jail in the first place.

The State's prison Realignment began to take effect earlier than Proposition 47 and was instituted in response to a directive from the Federal courts to California to reduce overcrowding in State prisons. Lower-level offenders were released back to County jails which, in turn, put pressure on County jail populations. The end result was often the release of non-violent offenders back onto the streets. Finally, shortly following the implementation of Realignment, California's voters approved Proposition 36, reforms to the Three Strikes Law, which resulted in the resentencing and release of over 1,000 inmates from California's prisons. Although one very preliminary report issued by proponents of the reforms recorded very low recidivism, it was measured after only six months beyond release, so more research will need to be completed to know the true outcome. Regardless of the circumstances we find ourselves in by what some might characterize as "soft on crime" changes in California law in the past few years, it behooves us to become prepared for the uptick in property crimes we have been experiencing.

## Ethics Commission Vacancy

APPLICATIONS are being accepted for the Ethics Commission. The San José Ethics Commission (Commission) monitors compliance with all campaign and ethics ordinances in the San José Municipal Code. The Commission reviews and investigates allegations of violations of the Code and makes recommendations for enforcement action where appropriate. The Commission also makes recommendations to the Council with regard to campaign and ethics regulations and policies. The Commission is charged under Chapter 12.04 of the San José Municipal Code to investigate complaints alleging violations of Title 12 of the San José Municipal Code and take enforcement action. Formal regulations are adopted by the City Council to ensure that all interested parties are apprised of and

understand the procedures by which a fair hearing will be conducted.

**QUALIFICATIONS:** The Clerk's Office is recruiting for up to three positions on the San José Ethics Commission to fill four-year terms ending March 1, 2019. Applicants must be registered voters in the City of San José and, if appointed, must remain so throughout the term of office. While serving on the Commission, no member can hold any other public office nor publicly endorse any candidate for City office or engage in any political or campaign activity on behalf of any candidate for City office. Further, no member can participate as a candidate in any election to public office for a period of one year before and after tenure on the Commission.

**APPOINTMENT PROCESS:** All applications received by the deadline will be submitted to the Mayor and Councilmembers who will notify the City Clerk as to whom they would like to interview. Applicants receiving four or more such indications of interest will be notified and asked to appear during a regular or special Council Meeting to be interviewed by the Mayor and Council. Applicants must receive a two-thirds vote of Council (8 votes) to be appointed to serve on the Commission. The tentative date scheduled for interviews is on Tuesday, February 10, 2015.

Applications will be accepted through 5:00 p.m., on WEDNESDAY, January 14, 2015.

To expedite completion of student financial aid applications, it is recommended that parents and students bring any of the following applicable items:

- Student's Social Security card and driver license or government-issued identification.
- Parent or guardian's Social Security card.
- If not a U.S. citizen, bring alien registration card; if you do not have an alien registration card, visit [dream.csac.ca.gov](http://dream.csac.ca.gov) to learn if you qualify for California Dream Act financial aid.
- Parent's Federal Income Tax return, current W-2 forms or other records of income.
- Records of untaxed income such as Temporary Assistance for Needy Families, veterans, or Social Security benefits.
- Student's W-2 forms, pay records or other records of income earned.
- Bank account records or bank statements.
- Records of stocks, bonds or investments.
- Business and farm records.
- A list of the colleges you are applying to.

## SENIOR COMMISSION VACANCY

About the Commission: The Senior Citizens Commission studies, reviews, evaluates and makes recommendations to the City Council on any matters affecting seniors in the City of San Jose, including health, education, employment, housing transportation and recreation.

The Senior Commission meets quarterly on the second Thursday of March, June, September and December during the day, at 1:30 p.m. In addition, Commissioners are assigned to a standing sub-committee that meets quarterly during the day. Senior Commissioners are assigned as liaisons to Senior Centers as well as other San Jose Boards and Commissions. Occasionally, they are expected to attend



meetings of the City Council, Rules and Open Government, and other Council Committees to represent the Commission.

The San Jose Arena Authority Board of Directors convenes monthly to identify and address issues relating to the management and operation of SAP Center at San Jose (home of the San Jose Sharks); Sharks Ice at San Jose (San Jose Sharks training facility and public ice rinks); and San Jose Municipal Stadium (home of the San Jose Giants).
