DISTRICT 10 COMMUNITY BUDGET MEETING

SAN JOSE ADDRESSES CALIFORNIA'S SEVERE DROUGHT

During the April 21st Council Meeting, the city's Environmental Services Department (ESD) issued a memo addressing the severe drought and water shortage issues our state is facing, and included recommendations on how to move forward in the conservation process. In the memo, the department suggested the Council adopt a resolution declaring a 25% water shortage in the City of San Jose which would, "limit the use of potable water for landscape and turf irrigation to two (2) scheduled days per week, except when watering by hand or by drip irrigation, or for maintenance of public parks, playing fields, day care centers, golf course greens, and school grounds, provided such irrigation is done in a water efficient manner, or for fire protection, soil erosion control, plants/trees grown for consumption, nursery/garden center plants for sale, and environmental mitigation projects."

Mayor Sam Liccardo and Councilmember Margie Matthews put forth their own memo recommending the Council take further action, and increase the water shortage declaration to 30%. This is what the Council ultimately adopted, with a couple of exceptions and clarifications. First, in the ESD's chart of Proposed City of San Jose Water Use Restrictions, the refilling of residential swimming pools and outdoor spas by more than one foot would have been prohibited under the 30% water shortage. The Council decided that residential pools and spas can continue to be refilled by more than one foot for the purposes of making essential repairs and fixing leaks. The restriction on refilling of residential pools and spas by more than one foot was moved to the 40% water shortage declaration level. With that said, the 30% declaration will continue to prohibit the construction and filling of new residential swimming pools. As long as the 30% water use restrictions are in place, there is a moratorium on the issuance of new building permits for residential swimming pool construction.

In addition to the actions taken by the City Council on April 21st, the San Jose City Council and the Board of Directors for the Santa Clara Valley Water District held a joint study session on the drought and water shortage issues. During that meeting, several valuable conservation programs were discussed, as well as the outreach tools needed to encourage everyone in San Jose, and surrounding areas, to take ownership of these challenges and do their part in conserving water.

The Santa Clara Valley Water District offers a number of rebate programs for things ranging from landscape conversion to high-efficiency appliance installation. The Water District isn't the only agency with programs such as these. The San Jose Water Company is currently providing free leak evaluations for your homes and businesses. FLY DIRECT FROM SAN JOSE TO BEIJING!

On Monday, June 15, 2015 Hainan Airlines will begin service on the first direct, round-trip service from the Silicon Valley to Beijing (PEK), China. For those of you who do business in China or who look forward to traveling to China for tourism, you no longer need to make the long haul to San Francisco and deal with the flight delays that plague departures out of SFO. Now you can benefit from the convenience and superior on-time departure record of Mineta San Jose International (SJC) when you fly to China!

Hainan Airlines flights will serve both coach and business class travelers. They are one of the few 5-star rated airlines in the world, according to Skytrax, an airline industry rating organization. If you book a flight before May 5th you'll receive a \$50 discount on your booking! [You may access their website here](#). I am thrilled that Hainan has chosen San Jose as it expands its direct roundtrip service between the Bay Area and Beijing! Growth at our airport is essential to maintaining the fiscal health of SJC, so I encourage you to support Hainan by choosing SJC for your travel to and from PEK to ensure this new route is successful!

The team at SJC has provided the following information:

Mineta San José International Airport's (SJC) newest international airline will begin service on June 15 with five flights per week on the modern and luxurious Boeing 787 Dreamliner. Hainan flights will depart SJC at 1:10 p.m. and arrive in Beijing at 4:40 p.m. the following day. The return flight leaves Beijing at 2:30 p.m., arriving at SJC at 11:10 a.m. the same day. Flight time is 12 hours, 30 minutes westbound and 11 hours, 40 minutes eastbound.

ADOPT-A-PARK IN DISTRICT 10

Out of all of these parks, there are 13 that have been adopted by either groups, like a neighborhood association or service club, or by individuals. These volunteers have committed to caring for our parks at various levels. Some simply pick up trash and report problems, such as broken equipment, to the Parks Department. Others organize volunteers to plant new plants and pull weeds. Will you consider adopting one of our 10 remaining parks? Up for adoption are: Almaden Lake Park, Chris Hotts Park, Comanche Park, Foothill Park, Glenview Park, Parkview I, II, and III, Pfeiffer Park, and Waterford Park. FLOOD PROTECTION PROJECT COMMUNITY MEETING

The Santa Clara Valley Water District is scheduled to break ground on the Upper Guadalupe River Flood Protection Project on May 28th. This project will include pulling out invasive species, repairing and improving native species, repairing the banks, and improving creekside access and view. On Wednesday, May 6th, at 6:00 PM, they are hosting a pre-construction event so the public can have the opportunity to know more

about the project and provide input. The pre-construction event will be held at the Pearl Avenue Branch Library.

K880 Emerging City Champions Fellowship

The K880 Emerging City Champions Fellowship is now open for applications from young civic innovators with ideas to make their cities more livable. Supported by Knight Foundation and led by 8-80 Cities, the fellowship is open to innovators based in the eight resident communities where Knight invests: Akron, Ohio; Charlotte, N.C.; Detroit; Macon, Ga.; Miami; Philadelphia; San Jose, Calif.; and St. Paul, Minn.

The fellowship will equip 24 young leaders with the skills, knowledge, and support they need to make immediate and lasting impact in their communities.

Successful applicants will receive:

1. A \$5,000 grant to implement their project idea.
2. An all-expense paid trip to the K880 Emerging City Champions Studio in Toronto, Canada where they will receive practical training from established civic leaders.
3. Ongoing support from 8-80 Cities and a professional mentor in their related field.

To be eligible, applicants must be:

- Between the ages of 19-35.
- Live in one of the eight Knight resident communities mentioned above. Their project idea must also benefit a community in that city.
- Available to attend the K880 Emerging City Champions Studio in Toronto in June 2015.
