II. Notes for Resource Table Participants

- The *primary* purpose of the resource fair at this event is *to distribute information* about community-based services, resources, or programs that may help individuals and families who are experiencing family/domestic violence and/or individuals who want to become involved in preventing and raising awareness about this issue.
- Agencies will be limited to 1 table maximum. (*Please note that you may be asked to share a table based on availability.*)
- Expected attendance at the Walk is approximately 800-1000 attendees.
- You **MUST** submit a completed Table Interest Form in order to be eligible to participate in the Resource Fair by Friday, September 10, 2010.
- Confirmations and additional information will be sent out to agencies who are interested in participating in the Resource Fair after completed Interest Forms have been received.
